## **Historical Note**

Eugene Rochow served on the board of the Matlovich Society, a Portland-based organization that provided an educational forum for the local gay, lesbian, bisexual, transgender, and questioning community during the 1990s. Founded in 1991 by K. Ronald McClinton, a former anesthesiologist at Mercy Hospital, and Lois Galgay Reckitt, a long-time activist and community organizer, the Matlovich Society held meetings twice a month featuring speakers presenting on various topics related to the LGBTQ+ community. Gene Rochow attended his first meeting of the Matlovich Society in October 1991. The organization continued to hold meetings until 1999, when membership had dwindled and the group disbanded.

McClinton named the group after Leonard Matlovich, a former member of the United States Air Force who was discharged from service based on his sexual orientation. Although Matlovich made headlines during the 1970s after his legal battle against the USAF, McClinton was distressed to learn through conversation that a young gay man had never heard about Matlovich, only two decades later. This realization inspired McClinton to establish the Matlovich society with the help of Lois Reckitt, to preserve the history and culture of the gay and lesbian community through education. When McClinton died that same year of complications due to AIDS, Howard Solomon, a Tufts University history professor, filled in as co-chair with Reckitt.

Over eight-and-a-half years, the Matlovich Society hosted a diverse range of speakers, including Congressman Barney Frank of Massachusetts, Tim McFeeley (former director

of the Human Rights Campaign Fund), Leslie Feinberg (author of *Stone Butch Blues*), and numerous other writers, musicians, and scholars. The group hosted social events such as alcohol-free cruises around Casco Bay, and an annual lawn party. Initially, meetings occurred in the Peoples Building on Bracket Street in Portland, where the group rented office space, before moving to the Portland Public Library and then to the Holiday Inn by the Bay as the group outgrew each space. More than 300 people attended some meetings, and the Maine Lesbian Gay Political Alliance recognized the Matlovich Society in 1992 for its service to the LGBT community.

In a 2004 interview with *Queertalk*, an LGBT-themed radio program on the University of Southern Maine's WMPG station, Lois Reckitt credited the Matlovich Society with inspiring many other initiatives such as the Maine Gay Men's Chorus, Equal Protection Portland, and a group of LGBT social workers. Reckitt stated that the Society ended due to its own success at integrating the LGBT community within Portland.

### **Description of the Papers**

The Eugene Rochow Papers document the Matlovich Society between 1990 and 1999, and other organizations and events in the LGBTQ+ community. The majority of the papers in the collection are records of the Matlovich Society that Rochow retained after the organization disbanded in 1999. The collection includes documents related to Equal Protection Portland, a 1992 initiative to pass and protect a Portland city ordinance to bar discrimination against homosexuals, and Maine LGBT newspapers spanning the years 1979 through 1997.

The Papers are organized into five series and their subseries:

#### **Series 1: Matlovich Society**

This series is divided into the following subseries: Administrative Documents, Correspondence, Fundraising, Programming, Advertising and Publicity, and Subject Files. This series includes bylaws, membership and mailing lists, budget information and meeting minutes, drafts for grant applications, brochures listing the Society's events and materials to the speakers it hosted, newspaper clippings, stationery, press releases, and materials related to the design process for brochures. Original folder titles and organization were maintained where possible.

#### **Series 2: Equal Protection Portland**

The documents in this series offer a glimpse into some of the strategies used to lobby for the Equal Protection Law in Portland, including a packet with examples of advertising from those opposed to the law, and instructions for those attending a public hearing on the issue. The papers also include examples of flyers and brochures used by the campaign.

### Series 3: Maine LGBT Publications

This series includes issues from four Maine newspapers for the LGBT community: Maine Magazine (one issue from 1979); Our Paper (issues spanning 1983–1993); 10% (1994–1995); and Community Pride Reporter (1993–1997). There are also sections from the Portland Press Herald from 1992.

Note: In 2007, Community Pride Reporter, Our Paper, and 10% were removed for consolidation into catalogued runs.

### Series 4: Restricted

This series consists of materials restricted from public access to guard the privacy of individuals. Listed within their regular series, the materials are included here to give their physical location. Materials include lists of organization members and correspondence containing addresses, phone numbers, and email addresses.

### Series 5: Oversize

This series contains materials too large or bulky to fit into regular archival boxes. Listed within their regular series, these materials are included here to give their physical location. Oversize materials include a Portland Pride Day proclamation plaque, posters for Equal Protection Portland, parade banners, t-shirts, and the program for “Bent,” a theater drama about “love and death during the Holocaust,” for which Gene Rochow served on the production staff. Additionally, the series includes a print of an Annette Dragon photograph.
