## **Historical Note**

Westbrook Citizens for Equal Rights (WCER) was a Political Action Committee (PAC) registered in Westbrook, Maine in June of 2002. WCER was formed to promote civil rights in Westbrook, and notably campaigned to uphold the Westbrook Human Rights Ordinance of 2002.

The introduction of the ordinance was initiated by Reverend Susan Gilpin, a citizen of Westbrook, after a gay couple in her neighborhood moved away because of routine harassment on the basis of their sexual orientation. Gilpin approached the City Council in February of 2002 about the issue, and was soon joined in her efforts by Michael Miles, the Human Resources Director at University of New England, and Tim Crellin, the chair of the School Board. Along with the council, the three began a local gay rights campaign and on July 29, 2002, the Council unanimously passed the measure, which intended “to correct and to prevent discrimination in employment, housing, access to public accommodations, and the extension of credit, on account of a person’s sexual orientation.”

However, some members of the Westbrook community, notably the Christian Coalition of Maine led by Executive Director, Paul Volle, opposed the ordinance, and were able to gather enough support to have the ordinance put on the November ballot in hopes of it being overturned by a public vote. On November 5, 2002, Westbrook citizens voted to uphold the ordinance, rejecting repeal with a narrow margin of 3,334 to 3,157.

## Description of the Archives

The bulk of the materials in this collection pertain to the Human Rights Ordinance that was proposed and passed in Westbrook, Maine in 2002. There is also information on the 2003 election in Westbrook, information on similar ordinance campaigns in Falmouth, Maine Kalamazoo, Michigan, and Traverse City, Michigan, and additional resource articles, speeches, and publications. The Archives are organized in four series:

### Series 1. Westbrook Human Rights Ordinance

This series contains campaign-related materials, including planning notes and outlines, flyers, brochures, newspaper clippings, campaign ads, volunteer instruction materials, and contact lists.

### Series 2. 2003 Westbrook Election

This series contains some information on the 2003 Westbrook City Council election, which took place a year after the referendum vote on the ordinance. Westbrook Citizens for Equal Rights wrote a letter to supporters of the ordinance reminding them which politicians had been supportive of the cause in the previous year. There is also a list of Maine legislative representatives included in this series.

### Series 3. Non-Westbrook Campaigns

Series 3 contains materials from three other anti-discrimination ordinance campaigns, one in Falmouth, Maine between 1999-2000, one in Kalamazoo, Michigan, and one in Traverse City, Michigan. The Falmouth campaign materials include copies of a minority opinion report presented to the Sexual Orientation Ordinance Committee by West Falmouth Baptist Reverend Dr. Alfred J. Fletcher, telephone scripts and talking point documents for volunteers, articles, print/ mailing estimate costs, and letters. The materials from Kalamazoo are three different ads opposing 'Proposal A,' which would allow discrimination against gays and lesbians. The materials from Traverse City are ads and flyers opposed to 'Proposal 1,' which also would allow for discrimination against gays and lesbians.

### Series 4. Resources

These resources include anti-gay materials from the Family Research Council and Americans for the Truth. There are also various opinion articles promoting gay rights.

### Series 5. Restricted

This series consists of materials restricted from public access to guard the privacy of individuals. Listed within their regular series, they are included here to give their physical location.

#### Series 6. Oversize

This series contains materials too large or bulky to fit into regular boxes. Listed within their regular series, they are included here to give their physical location.
