### **New Anti-Discrimination Bill Printed**

L.D. 2239 "An Act to Ensure Civil Rights and Prevent Discrimination" was released to the Legislature on May 24th. To announce the bill to the general public, MLGPA held a press conference on the following day; the story appeared in most of our daily newspapers, on many of our TV stations and Maine Public Radio. The bill has been carried over to the next session of the legislature, which begins in January 2000. We wish to thank (and you can, too) the following legislators for their sponsorship:

#### **IMPORTANT HIGHLIGHTS**

A great deal of thought has gone into the new anti-discrimination bill. While there are no changes in its basic provisions, the bill does propose new language to make it abundantly clear that the Maine Human Rights Act does not grant any "special rights" or "legislative approval." We believe that by putting those questions to rest, we remove the objections of many people who have not supported this measure in the past. Here are its key points:

▼ Discrimination in the areas of employment, housing, public accom-

modations and credit based on sexual orientation (heterosexual, homosexual or bisexual) will be prohibited.

- ▼ The bill will add sexual orientation to each section (employment, housing, credit and public accommodations) of the Human Rights Act, not just amend the policy section as in prior bills.
- ▼ The legislation and the ballot question both clearly state that the Maine Human Rights Act does not convey legislative approval of, or special rights to, any person or group of persons.
- ▼ Religious organizations and institutions that do not receive public funds will be exempt from this bill.

If passed by the 119th Legislature, this bill will go on the ballot to be

ratified by the citizens of Maine in the next general election, November 2000. The ballot question is incorporated within the bill and seeks a "yes" vote to ratify. It reads:

"Do you favor ratifying the action of the 119th Legislature whereby it passed an Act extending to all citizens regardless of their sexual orientation the same civil rights protections now guaranteed to citizens on the basis of race, color, religion, sex, age, national origin and physical or mental disability in the areas of employment, housing, public accommodations and credit and where the Act expressly states that nothing in the Act confers legislative approval of, or special rights to, any person or group of persons?"

### **Legislative Report**

The following report is our Legislative Wrap-up for the 119th Legislature. In all but one of these bills, the positions taken by the board of MLGPA prevailed. While this is great news, the fact that some of these bills were even submitted is cause for concern. We've got to mobilize more of our members to work with their local legislators and continue our strong legislative program. Included for each bill is the legislative document number (LD), title, sponsor, committee, and outcome as of June 3, 1999, such as Failed or Carried Over.

### CIVIL RIGHTS BILLS

LD 2239 "An Act to Ensure Civil Rights and Prevent Discrimination." Sen. Joel Abromson (and 12 cosponsors). Judiciary Committee. CARRIED OVER to next session, January 2000. NOTE: At the beginning of the session, 6 separate civil rights bills (which proposed amending the Maine Human Rights Act to prohibit discrimination based on sexual orientation) had been filed. Ultimately only this one bill, LD 2239, was printed.

<u>Committee Reports:</u> (Membership) Membership renewal follow-up phone calls are scheduled for Wed. June 9, 1999 at 6:00. Members who have not renewed by July 2, 1999 will be removed from the list for purposes of membership benefits. (Special Events) A process has been developed for obtaining sponsors for our special

events. MLGPA will have a table at Portland Pride on June 19, 1999. We will also be marching in the parade. Marchers are to be at Congress Square in Portland by 11:00 a.m. on June 19th.

(Legislative) We received an update on the civil rights bill being printed. The proposed bill will include the specific referendum question in it. The bill attempts to clarify and defuse issues raised by opponents in the past. For example, the bill expressly refutes an intent to create "special rights."

Agenda order: Our monthly meetings have been beginning at 6:00 p.m. with committee meetings. However, because this is a quiet time for many of our committees, we have decided to begin our meetings with general agenda items to make more efficient use of our time. Time will be allotted for committees to meet, if necessary at the end of the agenda.

<u>Fundraising Efforts</u>: We received an update on our major donor fundraising efforts. To date, we have more than doubled the funds raised in any one year.

### Human Rights Campaign Seeks Your Help

In January, Senators Jim Jeffords, R-Vt., Edward Kennedy, D-Mass., William Roth, R-Del., and Daniel Moynihan, D-N.Y., introduced S. 331: "The Work Incentive Improvement Act of 1999." The bill would ensure that a person with a disability, including someone with HIV disease, would have continued access to adequate and affordable health insurance when he or she returns to work. Currently the risk of losing access to new treatments for HIV by giving up federal health benefits, like Medicaid, often prevents people with HIV or AIDS from seeking employment.

Maine's Senators Snowe and Collins are among 74 Senators who have co-sponsored S. 331, and the bill will

pass overwhelmingly—if Majority Leader Trent Lott, R-Miss., schedules the bill for a vote.

The Human Rights Campaign urges you to contact our senators to express your support for this legislation and to ask them to urge Senate Majority Leader Trent Lott to schedule S. 331, as it is written, without changes, right away.

LD 571 "An Act to Prohibit Partial Birth Abortions." Rep. Adam Mack. Judiciary Committee. FAILED.

LD 917 "An Act to Ban Partial Birth Abortion Except to Protect the Life of Health of the Mother." Rep. Robert Cameron. Judiciary Committee. FAILED.

LD 1593 "An Act to Ban Partial Birth Abortion." (BILL INITIATED BY PETITION) Judiciary Committee. FAILED. Note: Because it was not passed by the legislature, this issue goes on the ballot this November.

LD 2123 "An Act to Require a 24-Hour Waiting Period Before an Abortion May be Performed." Rep. Douglas Ahearne. Judiciary Committee. FAILED.

#### RELATED WORK BY MLGPA

In addition to the preceding 32 bills, MLGPA also monitored, and in some cases did preparatory work on, over 24 other proposed bills (including six civil rights related bills, two HIV bills, about 15 anti-choice bills, and some miscellaneous others), which never emerged as printed bills.

MLGPA's lobbyist, Susan Farnsworth, submitted written testimony for MLGPA on 23 of the above-named bills, as well as attended various hearings, work sessions, and floor debates on a couple of dozen key bills from the above list.

In addition, Susan tracked legislation by topical and statutory computer search on a weekly basis throughout the session, and did a visual scan of all bill titles & most amendments as they were printed. (A total of 2252 bills were printed during the 119th session!) In April, MLGPA organized the very successful Equality Begins At Home (EBAH) luncheon at the State House, attended by nearly 40 GLBT organizations and at least 60 legislators. MLGPA also held a news conference to announce LD 2239 "An Act to Ensure Civil Rights and Prevent Discrimination," when it was printed in late May.
