Maine Diversity Alliance to hold Leadership Institute

We're looking for a few good Lesbians, Gay, Bisexual and Transgendered people! MLGPA's educational foundation, the Maine Diversity Alliance, is sponsoring a unique Leadership Institute on December 2–5. This will be a nonpartisan, intensive, 3½ day training in all major areas of an electoral campaign for people who are serious about taking a leadership role in future electoral campaigns here in Maine.

Topics to be covered include:

- 1. Strategic planning what is a campaign plan & how do its parts fit together
- Building a volunteer base develop a leadership team and recruit lots of volunteers
- 3. Voter ID how to reach supporters, educate the undecided & measure our progress
- 4. Message and media how to express the issues and work with the press
- 5. Campaigning Skills how to communicate one-on-one with voters
- Countering homophobic anticipating & responding to attacks from the opposition
- 7. Fundraising how to raise the money to run a strong state-wide effort

Last year we held community meetings from Ogunquit to Caribou to discuss the failed referendum campaign and ways for us to move forward for LGBT civil rights. The single most important recommendation we received from just about everyone was to do more education and grassroots organizing in rural Maine.

Since then, through a series of statewide meetings — all on weekends in Bangor so that everyone could attend — we've helped establish a new coalition, the Maine Coalition for Equal Rights. And with your generous financial support we've retained a professional community organizer to increase our activist base. But one of the biggest reasons for the urban/rural split in the past has been the uneven distribution of campaign expertise. This training is our answer.

With the help of Dave Fleischer and the Policy Institute of the National Gay & Lesbian Task Force we have developed this program. And to make sure we reach all of Maine in the next referendum campaign, we want to offer this training to two people each of our 16 counties. Course graduates will bring new expertise to their rural counties and make a significant difference in the next campaign. It could be the foundation for a true grassroots effort, run by local people at the local level.

Over the past five years Dave Fleischer has conducted dozens of courses in electoral skills for the bipartisan Gay & Lesbian Victory Fund, the only national group dedicated to providing financial and technical support to qualified openly gay and lesbian candidates. Those from Maine who have attended one of these

One Member's Opinion...

As a physician in 1958, I saw the ruined life of an adolescent near term. She had been impregnated by her uncle. She and her family had been unable to consider ending the pregnancy early on because abortion for any reason was illegal. Many of the illegal abortionists of the day were in it for the money, treating their patients with haste and using contaminated instruments. She had avoided them and was alive, but she suffered the loss of her childhood at the age of 12.

In 1969 I worked with a mother of two teen-aged children to obtain the legal abortion that she and her husband desired. She had to meet with a minister 40 miles away to arrange for a flight to an abortion clinic in Mexico, the closest place where an abortion was legal in those days.

In 1979 I found myself the head of the Dayton (OH) Area Religious Coalition for Abortion Rights because I believed that women have the right to make their own decision regarding their lives. I realized that making the decision to have an abortion is exceedingly personal and exceedingly difficult. To revoke the Supreme Court decision of Roe v. Wade would take us back to the time when such decisions were immeasurably burdened with both medical and legal intrusions, into a matter which concerned a woman and her doctor.

As a father in 1983, I was greatly relieved that my daughter was able to go through with an abortion early in her pregnancy. She had found herself pregnant for the first time shortly after discovering that her husband was a felon. At the same time he had become physically abusive of her. She had just separated from him. To go through with a pregnancy conceived with him was too much for her to deal with.

The November 1999 referendum that voters face asks us to make certain abortions illegal. This is another step in the strategy of anti-abortionists to make all abortions illegal again. The anti-abortionists' referendum is similar to those already found unconstitutional in other states. Despite this, they would have us turn back the clock. returning to a climate where abortion is effectively denied women and children in situations similar to the ones to which I've been a witness.

Roe v. Wade must remain the law of the land. Vote against the anti-abortion referendum this fall.

MLGPA attends Federation Meeting

MLGPA joined member groups from 45 states and the District of Columbia for the meeting of the Federation of Statewide Lesbian, Gay, Bisexual and Transgender (LGBT) Political Organizations in Minneapolis in July. Founded just two years ago with the support of the National Gay and Lesbian Task Force, the Federation has grown rapidly; there were just 36 members in 1998. MLGPA's Lobbyist Susan Farnsworth and V.P. Dave Garrity attended the four full days of training and information sharing, which were coordinated by NGLTF.

The focus was on grassroots organizing, legislative strategies and growing our base at the state level, and there were presentations from a number of national groups and political parties on what the elections of 2000 may mean to us. Workshop topics included: transgendered inclusion; organizing and working with gay youth;

and, understanding and responding to the radical right. It seemed that every state was engaged in one or more legislative effort over hate crimes, civil rights, adoption, sodomy repeal, marriage or domestic partnership.

We also reviewed the success and discussed the future of Equality Begins at Home Week last March, when 350 events were staged in all 50 states to highlight and encourage grassroots and legislative efforts on behalf of our LGBT communities. Most seemed to agree that the EBaH message applies to all the work we do, and that we should hold future EBaH events at any time of year. MLGPA is already planning to repeat early next year our successful "Expo of Maine LGBT Organizations and Lunch at the State House," which was attended by 60 legislators and introduced them to 40 of Maine's LGBT groups.

But, out of everything we learned that week, the most reassuring for us was to find out there are lgbt activists in other states who are even more hopelessly dedicated and ridiculously overworked than we are! Our thanks to the Maine Community Foundation for the gift that made this discovery possible.

training in the past — Dale McCormick, State Rep. Michael Quint, Jim Martin, Pat Peard, and MLGPA President Betsy Smith — have already demonstrated its value by their own achievement and leadership in our community.

We're only looking for people who are seriously interested in taking this course. Not only will it take a substantial amount of one's time, but it also requires a serious commitment to work on a future campaign. While we won't be charging a specific fee for the training, we will ask for an "inkind" pledge from everyone in lieu of a tuition. Options would include a commitment to raise \$1000 for next year's referendum campaign (or other worthy cause) by March 15, 2000, OR, a commitment to identify 250 gay or pro-gay voters by the following election day, OR, to recruit 50 volunteers and 5 volunteer coordinators.
