PREFACE

Local public records are of preeminent importance in documenting the most fundamental undertakings of government and of individual citizens. While the Maine State Archives is the central repository for non-current records on the State level, most records generated by lower units of government have remained in the continuous custody of local officials. This directory is intended to assist the researcher in determining the location and availability of existing municipal and county records.

This directory is a revision of the preliminary edition of 1972, printed for limited distribution, which was very favorably received. Again, the directory is divided into two major parts: Part I, Municipal Records, surveys the record holdings of the State's plantations, towns and cities in alphabetical order; Part II, County Records, likewise surveys the State's sixteen counties. Unlike the previous edition, the names of the responsible municipal and county officials are not given, due to the impossibility of keeping such information current. It is suggested that the Maine Municipal Association's Municipal Directory be consulted for the most recent listing. Rather, the amount of information about the records themselves has been expanded to provide the researcher with as much detail as possible, particularly the inclusive dates of record series and descriptions of losses by fire or other means. It should be noted that all Superior and Supreme Judicial Court records (together with those of their predecessor courts) prior to 1930, have been transferred to the Maine State Archives in Augusta for permanent preservation. Records of the former Municipal Courts are likewise in the custody of the Maine State Archives.

It is hoped that this edition of Public Record Repositories in Maine represents an advancement toward the goal of a comprehensive system of information about the public record resources of the State. In the effort to make future revisions of this directory increasingly more accurate and complete, corrections of errors and omissions made in this volume are welcomed.

Grateful acknowledgement is given to the municipal and county officers and to Rebecca Robbins of the Maine State Archives staff for their invaluable assistance in the compilation of this directory.

INTRODUCTORY NOTES

The abbreviation MSA is used to denote the Maine State Archives. "Film at MSA" refers to that taken by the Church of Jesus Christ of Latter-day Saints (Mormons), copies of which are available for research in the Search Room.

The dates given for the organization and incorporation of municipalities and the establishment of counties are, unless otherwise stated, the dates on which the enabling acts were passed by the Legislature. In cases where the responsible officials could not be contacted and/or completed questionnaires were not received, the 1972 entries were simply updated through 1976.
