## New Dean Named for SBEM

### Other Changes Pending

Robert A. Patton has been named the new dean of the School of Business, Economics and Management. The University of Maine Board of



Trustees last week approved a three-year renewable appointment for Patton, effective January 1, 1992. John Bay is

serving as acting dean this semester, succeeding Richard J. Clarey. After five years as acting dean and dean, Clarey returned to the faculty on September 1.

Patton, who was chosen from a field of 64 applicants, was the dean of the College of Business Administration at Bowling Green State University in Ohio from 1984 to 1990 and acting dean for two previous years. He is currently professor of applied statistics and operations research at Bowling Green. He holds a Ph.D. in statistics from the University of Missouri, where he taught from 1961 to 1967 before joining the Bowling Green State faculty in 1967. At Bowling Green he also chaired the departments of Quantitative Analysis and Applied Statistics. He has written on statistics and operations research for publications in economics and managerial decisions.

Patton also will join the faculty of the Department of Business Administration as professor of finance. He will be eligible for tenure in the second year after leaving the deanship.

An important undertaking for the new dean will be guiding the school through the AACSB accreditation, along with goals of promoting faculty

research and scholarship and increasing ties with the local business community.

Patton emphasized his respect for the achievements of the school to date. "I have been impressed not only by the quality of the faculty and staff of the school," he said, "but also by their professional aspirations and personal concerns for the growth and development of students, the school, the university and the community. I am excited about joining the dynamic new leadership of the university and assisting the school in reaching its full potential."

Serving on the search committee for the deanship were Bruce Andrews, associate professor of business administration; Michael Hillard, assistant professor of economics; Robert Hird, director of research and advanced study for SBEM; Brian Hodgkin, dean of the School of Applied Science; John Houlihan, professor of business law; Kenneth Krenzin, assistant professor of business administration; student Linnea Olsen; Sally Paterson, assistant to the dean, SBEM; Daniel Quinn, member of the SBEM Business Advisory Committee; Linda Richardson, assistant professor of finance; John Sanders, associate professor of associate business administration; George Violette, assistant professor of accounting; and James Westfall, associate professor of associate business administration. Philip Jagolinzer, professor of accounting, chaired the committee.

A search is now nearing completion in the School of Nursing for a new dean. Committee Chair Jan Burson said that interviews with candidates have been conducted. The two finalists are Betty Johnson, Ph.D., R.N., professor and former director of Off-Grounds Programs at the University of Virginia School of Nursing, and Patricia Yoder Wise, Ed.D., R.N., executive associate dean and professor, Health Services Center, School of Nursing, Texas Tech University. Members of the SON search committee

## Two Libra Professors Named

At the recommendation of the School of Law, the Board of Trustees appointed Orlando E. Delogu Libra Professor in

Law through August 31, 1992. The Libra professorships were established to recognize and support academic excellence and were



made possible by a gift of \$5 million from Elizabeth B. Noyce in 1989. The Board of Trustees authorized 20 Libra Professorships through the University of Maine System, with five being awarded at USM. The Libra Professorship of Law was the first USM Libra position.

The Law School awards the endowed professorship, which carries an annual stipend, on a rotating basis to faculty members selected for their proposals for major research. Delogu, who will receive \$14,000 for the year in support of his research, will continue his research on shoreline access. He replaces Michael B. Lang, who was awarded the first Libra Professorship of Law for a two-year term through August, 1992 but who is spending this year on sabbatical. Lang will complete his work on tax accounting begun last year while on sabbatical.

Delogu recently finished a report for the Cumberland Town Council which identified two public claims to the coastline, reaching back to colonial times. He reviewed deeds, grants and legislation from the colonial settlement of North Yarmouth, which today includes the towns of Cumberland,

## Exploring Columbus

The first lecture in a series of events exploring the legacy of European-American contact and the voyages of Columbus to the New World will be held at 6:30 p.m. on Monday, October 7 in Luther Bonney Auditorium. William Keegan, curator of Caribbean anthropology at the University of Florida, will give a talk "Columbus Was A Cannibal (And Other Myths about the European Exploration of the Americas.)"

The lecture has been scheduled by USM's Columbus Quincentennial Committee, appointed by President Richard L. Pattenaude to serve as a clearinghouse on information about activities related to the 500th anniversary of Columbus' first voyage to the Western Hemisphere. The committee will coordinate events at USM and serve as a liaison with the Portland community on Quincentennial activities. The committee is chaired by Judy Tizon, associate professor of

anthropology. Serving on the committee are Nathan Hamilton, assistant professor of archaeology; Faith Harrington, assistant professor of New England studies; James Messerschmidt, associate professor of sociology; Alfred Padula, associate professor of history; Dave Davis, dean of the College of Arts and Sciences, and Harold Osher, donor of USM's Osher Collection of antique maps and globes.

The committee hopes to hold events which provide a critical look at all aspects of the legacy of European-American contact, Judy Tizon said. The committee has recommended that the legacy of the Columbian encounter be a theme for Convocation, which could also encompass pluralism issues. They hope for event suggestions and participation from the USM community and especially hope for input from Native American students. Anyone interested in contributing ideas should contact Tizon at 780-5060.

The first lecturer, William Keegan, earned his Ph.D. at the University of California at Los Angeles and is a specialist in economic anthropology. He has researched island colonization, the prehistory of the West Indies and the period of contact between natives of the Americas and Europeans. A principal interest of Keegan's has been the search for the site where Columbus actually landed. He has conducted excavations in the Bahamas, Granada, Florida and other North American sites.

Keegan will discuss the native American perception of the European colonists and how the arrival of the Europeans was interpreted by these people in terms of their own mythology. He also will cover the misinformation which Columbus took back to Europe about the Americas.

Yarmouth, North Yarmouth, Pownal, Freeport and Harpswell. His research found rights reserved for the public along the foreshore and within the intertidal zone. Historical claims of this sort were not precluded by the 1989 Maine Supreme Court decision in *Bell v. Town of Wells*, known as the "Moody Beach" decision, that excluded the public from using privately-owned shorefront. Delogu's Libra project will research strategies which Maine towns or the state could pursue to reclaim shoreline areas for public use. Towns could use their tax, bonding, eminent domain and spending powers to accomplish this goal, Delogu says. "How eminent domain might best be used to minimize total public costs in the acquisition of public use rights in the intertidal zone...is an aspect of the problem that is of great importance and interest." Delogu has been interested in this subject for 10 years and has worked on judicial and legislative fronts to protect public rights to the intertidal zone.

Delogu, who holds a master's degree in economics and his law degree from the University of Wisconsin, has been on the faculty of the Law School since 1966. He has served on state committees and consults with federal, state and local governmental agencies, land-use planning firms and law firms on land-use law, environmental and natural resources law. His numerous publications have been in the same fields, including his recent book "Maine Land Use Control Law." Delogu was a co-founder of the Maine Civil Liberties Union, past MCLU president and board member, and former member of the National Board of the ACLU, board member of the Center for Natural Areas, and chair of the Section on Environmental Law of the Association of American Law Schools. He was a research fellow in Germany for the International Council on Environmental Law in 1973-74, visiting scholar at University College Galway in Ireland in 1981 and at Essex University in England in 1989.

Delogu recently visited Thailand under the auspices of USAID and the World Environment Council to assist the Thai government in developing a range of new environmental initiatives to address severe air and water pollution.

The Board of Trustees also has appointed the first Libra Professor of Humanities at USM as recommended by the Libra Committee for the College of Arts and Sciences. The college has

determined to use the endowment as a visiting appointment to bring to campus "outstanding scholars to lead multidisciplinary examinations of major topics in the humanities."

Martyn J. Bowden will serve as Libra Distinguished Visiting Professor from January 1 through May 31, 1992 while on sabbatical from the Graduate School of Geography at Clark University. Bowden will give public lectures on the theme of "The European Vision of New England" and will guest lecture in geography/anthropology, history and New England Studies courses. He will also offer a series of workshops on the uses of USM's cartographic collections.

Guidelines for the Libra Distinguished Visiting Professor state that the recipient be a senior scholar of national or international reputation. Bowden, who earned his Ph.D. from University of California at Berkeley, has received grants from the National Science Foundation and the National Endowment for the Humanities on geographic topics and was a visiting geographic scientist for the Association of American Geographers.
