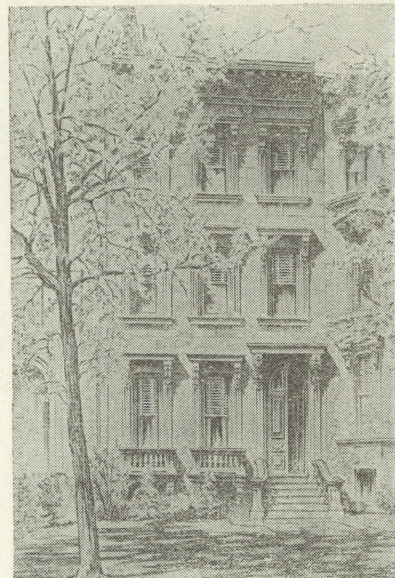


Dear Mayor:
