History

According to its by-laws, "Transsupport is a non-profit, educational, non-sexual and social peer group/support group for individuals, their families, friends, and anyone who desires a better understanding of gender related issues." During the period covered by the Archives, the organization served cross dressers, transsexuals and other transgendered persons and their families by offering: programming that promoted acceptance; a safe and private environment for cross dressing; and emotional support. Transsupport also acted as an information resource about gender issues and related services.

Membership in the organization was open to cross dressers, transsexuals, transgenderists, spouses, and significant others. However, members were required to go through an interview process before joining in order to ensure the security of the group and the individual's willingness to adhere to the organization's rules of conduct. Members came from all around Maine, including Portland, Bangor, Rockland, and Old Orchard Beach, among other cities and towns. Some members came from New Hampshire, as well. Meetings were typically held monthly, often in Brunswick, ME. A newsletter shared information with the membership. Transsupport had a resource library, as well.

Security and confidentiality were extremely important to the group. This included protecting the identities and contact information of members, imposing rules to ensure that anything said at meetings remained private, and dismissing members who violated the security guidelines of the organization.

Description of the Archives

The Archives contains papers documenting the organization and activities of Transsupport, including articles of incorporation, by-laws, security guidelines, rules of

conduct, minutes from Board meetings, and financial materials documenting income and expenses. Also present are newsletters documenting the organization's meetings, programs, and other offerings, as well as some personal testimonials.

The Archives contains some materials restricted from public access to guard the privacy of individuals. Wherever possible, the private information (names, addresses etc.) has been blacked out on a photocopy of the original document, so that the non-private information is still available to the public. The original documents containing private information are located in the Restricted box.
