# **Historical Note**

In May of 1997 the Maine legislature passed an anti-discrimination law that protected people from discrimination on the basis of sexual orientation. However, the provision was repealed by voters in a special election on February 10, 1998.

Devastated by the results of the vote, Linda Kizer a member of the Unitarian Universalist Society of Bangor, Maine started the Golden Ribbon Campaign, in which participants wore a gold ribbon symbolizing the golden rule: "do unto others as you would have them do unto you." Inspired by Kizer's campaign, the pastor of the Unitarian Universalist Society of Bangor, Sue Jamieson, and her partner Diane Campbell started working with another member of the congregation, Ron Hersom, on the possibility of having a Civil Rights March in Maine.

The group began reaching out to other activists, faith groups, and universities in Maine, ultimately forming the Maine Civil Rights March & Rally Committee. Committee members included Ron Hersom, Hugh and Eda Morrison, Linda Kizer, Janet May, Sue Jamieson, Diane Campbell, Eric Brown, Joan R. Day, Adella Reidt, Becky Rae, Kris Broski, Oreo Nalley, Pat Hofmaster, and Jean Lavigne.

The Committee held the Maine Civil Rights March & Rally on October 10, 1998 to draw attention and voice opposition to the February vote. The march was a 10 mile walk from Orono, Maine to Bangor, Maine. Three hundred people participated in the walk and about 800 joined in the rally following the march.

A week later on October 18, 1998, the Maine Civil Rights March & Rally Committee organized a vigil and memorial service in honor of Matthew Shepard, held in Bangor, Maine at the Hammond Street Congregational Church. Shepard was a gay college student at the University of Wyoming who was the victim of a hate crime on October 7, 1998. Two young men, Aaron McKinney and Russell Henderson, led Shepard to a remote area outside of Laramie, Wyoming, tied him to a split-rail fence and severely beat him. Shepard was discovered tied to the fence and still alive18 hours later by a passing cyclist. He died in the hospital several days later as a result of his injuries.

The Maine Civil Rights March & Rally Committee also held an interfaith vigil titled *Stop the Hate: Interfaith Vigil Against Hate Violence,* a year later on October 7, 1999, the anniversary of the crime perpetrated against Matthew Shepard.

Shepard's death had sparked discussion and debate about expanding hate crimes legislation in the United States, but it was not until October of 2009 that President Barack Obama signed the Matthew Shepard and James Byrd, Jr. Hate Crimes Prevention Act into law. The Act expands the 1969 U.S. federal hate crime law to include crimes motivated by the victim's gender, sexual orientation, gender identity, or disability.

In Maine, legal protection against discrimination based on sexual orientation was attempted and failed again in 2000, but was finally achieved in 2005 through a law passed by the legislature, signed by the governor, and upheld by voters through referendum.

# **Description of the Archives**

The materials in this collection pertain to the activities and events of the Maine Civil Rights March and Rally Committee. The archives are arranged chronologically, beginning with information about the referendum vote overturning the inclusion of sexual orientation in the Maine Human Rights Act in 1998 through the Golden Ribbon campaign, the Civil Rights March and Rally, and the Interfaith Vigil Against Hate Violence in 1999.

Notably, the archives contain five VHS tapes, which have a total of about 15 hours of footage from the march and rally, the Hammond Street candlelight service, the Matthew Shepard memorial service, the Civil Rights Celebration at the Maine Center for the Arts, the MCRMRC press conference, and numerous interviews. The footage was taped by two documentary filmmakers who had the intention of making a documentary film about the movement.

VHS #1 primarily has footage from the march itself, the rally, the interfaith candlelight service before the march, interviews, and the press conference with Ron Hersom, Sue Jamieson and other faith and community leaders, announcing the march and rally.

VHS #2 has interviews with Reverend Sue Jamieson and Ron Hersom, footage of musical performances from the Civil Rights Celebration at the Maine Center for the Arts, and footage from the march and rally.

VHS #3 has footage of musical performances from the Civil Rights Celebration at the Maine Center for the Arts, and of the rally.

VHS #4 has musical performances from the Civil Rights Celebration at the Maine Center for the Arts, interviews and footage from the Matthew Shepard memorial service, the Hammond Street Church candlelight service, and other interviews.

VHS #5 has footage from the Hammond Street Church candlelight service.
