### Increased Online Presence: Edmodo and Dropbox

In an effort to create more of a CRTP community and make our content more accessible, we've increased our online presence. Specifically, we've moved more of our content online so that you can easily access it whenever and wherever you need it.

So where is it?

It's on Edmodo. Access the library there and you'll have a permanent collection of our most important content. You can access the library by clicking on the open book icon in the upper left corner of your screen once you login.

And it's on Dropbox. Dropbox offers online storage for all the important CRTP documents and files. You can access them anywhere, anytime without even having to create an account. It's like a permanently available toolbox.

But some of the content here will nudge/push you online, where the content is more timely and accessible. I respect the fact that many of us are more comfortable reading a traditional newsletter. You can still have that, but it's time to embrace the possibilities that online content and communication offer the CRTP.

### Project Ideas and Initiatives

In June I promised that I'd create a series of 20-25 project ideas and initiatives. They would all bear the CRTP seal of approval and help direct you and your teams towards best practices in addressing issues of bias in your schools.

I am pleased to report that those project ideas and initiatives are completed. You've got 20 to pick from, and they are diverse. Some are appropriate for all ages while some are best targeted for a specific age group. Some are small in scale while some require major



commitment. Some are detailed action plans while some are more general and open-ended. You should have no problem finding something that you can use.

Perhaps you are wondering just *how* you find these project ideas and initiatives. I've tried to make it easy for you. I've compiled all 20 of them into one document, complete with a table of contents and individual descriptions, but also separated them into 20 separate documents. Access as many or as few as you want.

But *where*? Through Edmodo, Dropbox, or directly from me.

This is pretty exciting news, but perhaps best of all... I've got plenty more ideas! I'm going to create even more of these project ideas and initiatives in the future; prepare to be overwhelmed with great ideas.

(All of these weeks are CRTP creations except No Name-Calling Week, which is sponsored by GLSEN.)

I will also offer all these presentations in Aroostook County the week of April 7-11.

## **Elementary Training Scenarios**

In an effort to help elementary school advisors keep their teams focused on issues of bias, I've created a series of 20-something scenarios. These scenarios will help elementary school students identify examples of bias behaviors that might occur in a school setting. Through repetition, students can reach a point where they learn to recognize the bias in the scenarios.

I went out and got the best people I know to help you achieve this. The Maine Youth Action Network (MYAN) is dedicated to "empower and prepare youth and adults to partner for positive change," and they'll be conducting a two-hour workshop in the afternoon focused on how you can get the most out of your students this year.
- **The Eiffel Tower!** The world's tallest iron structure will be playing a significant role in this year's advisor trainings, because... well, why not?

We look forward to seeing you soon at the advisor trainings. It always energizes us here at the CRTP, and our goal is to have you feeling the same.


