The undersigned, officers of a corporation duly organized at Red Men's Hall in the City of Bath, State of Maine, on the fifteenth day of March A.D. 1920, hereby certify as follows: The name of said corporation is Base Isroall. The purpose of said corporation are: To promote and conduct religious work, with the power in said corporation to take and hold by purchase, gift, devise or bequest, personal or real estate.
