## Community Discusses Civil Rights Coalition

Meetings are plentiful in our community, but few are as positive in tone or as productive in setting forth our options as was the first statewide "Coalition" meeting in Bangor on September 12th. This was the natural next step in MLGPA's efforts to bring people from around the state together to discuss what we need to do to attain civil rights.

We began by agreeing on some basic assumptions about our community:

- ▼ The Maine Human Rights Act should be amended to prohibit discrimination based on sexual orientation.
- ▼ We need to educate ourselves about the reasons people voted against us.
- ▼ We need to counter the "special rights" claim and other misconceptions.
- ▼ We need to do a lot more work in rural areas.
- ▼ We need to do more grass-roots organizing.
- ▼ We need to get more people of all orientations to do this work.
- ▼ No one group can do this alone.
- ▼ We need to start this work now.

Following agreement on these assumptions, five options were presented for moving forward (listed below with presenters):

- ▼ For the foreseeable future do education only, Mitzi Lichtman
- ▼ Pass local ordinances as broadly as we can throughout the state, Paula Stockholm
- ▼ Initiate a signature drive to put a referendum question on the ballot, Ethan Strimling
- ▼ Pass a civil rights bill in the Legislature, Sive Neilan
- ▼ Pass a civil rights bill in the Legislature and have the Legislature send it to referendum, Rep. Michael Quint

In the discussion that followed, it was clear that all options included education as a major component. But even with over an hour of discussion, we had only just begun when time ran out. After a discussion of the Civil Rights March and Rally on October 10 in Bangor, we made two decisions:

- 1) To attend the March and Rally on October 10, and
- 2) To hold the next Coalition meeting on the same afternoon (October 10) from 4-6 pm at the UU Church in Bangor.

We will have minutes available at the next meeting for new people to catch up quickly, and more information will be presented. Legal and timing questions will be addressed and there will be plenty of time for open discussion. **EVERYONE IS WELCOME!! BRING YOUR FRIENDS!!**
