TO: Governor James B. Longley and State Departments

Planning activities have increased rapidly at all levels of government during the past few years. This has been due to the need for organizing and administering an increased number of regulatory programs and providing an additional number of state services called for under new state legislation. Program and policy plans now affect nearly every agency. However, since the enactment of the state planning law, nearly eleven years ago, there has not been a major assessment of the overall state level planning system. Given the recent federal review of planning requirements and the resultant call for plan and planning process simplification, the need is evident to evaluate Maine's overall planning system.

In the near future, a report will be published by the State Planning Office giving an assessment and analysis of the Maine state planning system. Prior to its publication, however, a draft of the report will be circulated to state, regional, and local agencies for their review and comment. The attached inventory of state agency plans will serve as one important source of information for that publication. It also constitutes an effort to identify the extent of state planning in Maine. The "Inventory of State Plans" results from a 1977 survey of agency plans, updated in September 1978, that was conducted by the Maine State Planning Office. This survey was undertaken as one effort toward fulfilling Governor Longley's Executive Order No. 5 of October 17, 1975.

First, I want to thank the many representative state agencies and regional planning commissions for their cooperation in the review of state agency plans. This inventory could not have been made without their assistance.

Secondly, the assistance of my staff, particularly the Division of Comprehensive Planning Assistance in drafting the inventory and in collecting and indexing state agency plans, have made this report a reality.

Finally, I hope this inventory will serve as a source of information and as a building block toward improving the state planning system in Maine.

INTRODUCTION

During 1977, the State Planning Office made a survey of State agency plans in an endeavor to obtain a better picture of State agency planning activities. The survey was undertaken through questionnaires which were sent to a variety of State agencies and then followed up by personal visits and telephone calls. The survey was also made in response to Governor Longley's Executive Order No. 5 of October 17, 1975, which called for progress toward development of a State policies plan. This is the first time the attempt has been made to collect and index State agency plans.

In September, 1978, the survey was updated through telephone interviews and later the draft inventory was distributed to all State agencies and regional planning agencies as part of a draft document entitled, "Assessment and Analysis of the Maine State Planning System". The original intent was to publish the "State Plans Inventory" as a part of this report. However, it soon became apparent that a great deal of thought and work needed to be applied to the analysis of the draft report as it constituted a very important document. However, as the inventory data aged, it became necessary to publish this information before it became outdated. In recognition of this fact, the State Plans Inventory is being published separately from the Assessment and Analysis of the Maine State Planning System report which will be published during the first quarter of 1979.

The aim of this inventory is to identify and describe those plans prepared by State agencies which have an impact on the entire State or its major regions. Such an inventory also sheds light on why these plans have been developed. Four types of plans are included in this inventory: policy plans, program plans, study and recommendation plans and combined policy and program plans. Agency publications which contained only statistical data, inventories and other types of information which do not indicate future directions or actions are not included as plans.

A policy plan is defined as a statement of goals and objectives, formally adopted or endorsed as a guide to action by an agency, group of agencies, the Governor, or the Legislature. A policy plan may therefore cover a program, a group of interrelated programs

(which may be located in different departments) or it may be a plan that sets forth the general direction in which a particular administration wishes to proceed that affects many, if not all, State agencies.

A program plan is a document which details a series of actions to be taken in pursuit of established policies. Further, these plans indicate the specific agency commitments in terms of financial and personnel resources required to carry out the actions called for. This type of plan guides implementation of the agency's program(s). They usually have a short range focus and are prepared on a regular basis such as a fiscal year. Most federally required State plans are identified as program plans.

A study and recommendation plan is an initial sign of planning activity within a certain subject area due to growing public concern and consists of a problem survey, and consideration of a number of alternative solutions, with recommendations for a specific course of action to be followed. This type of plan is advisory to decision makers with no commitment of resources to its recommendations. Examples of these plans are task force or commission reports, inter-departmental studies and consultant studies.

A policy and program plan. In a number of instances, the responding agency could not identify its plans as either strictly policy or program plans. In these instances the reporting agencies combined them into a policy and program plan category.

Over twenty agencies participated in this inventory effort. With these responses, and a review of other data resources, 143 plans were identified. Agencies indicated whether a plan was prepared (1) to meet a federal requirement, (2) to meet a requirement of State law, and/or (3) for use in internal agency policy or program planning. Seventy-three (51%) of the plans were prepared to meet federal funding requirements. Fifty-four plans (38%) were developed by State agencies for use in internal policy and/or program planning and sixteen (11%) were developed to meet specific requirements in State law (See Table 1).

The types of plans prepared throughout State government are summarized in Table 2. Forty-nine (34%) are program plans, 40 (28%) are combination policy and program plans,

22 (16%) are policy plans, and 32 (22%) are study and recommendation plans.

The complete inventory is contained in the State Plans Inventory section of this report. Agency plans are organized by functional policy areas as defined by the State Bureau of the Budget. These eight policy areas are: General Government, Economic Development, Education and Cultural Services, Human Services, Manpower, Natural Resources, Public Protection, and Transportation. In each policy area, plans are listed by department and by bureau. A preface before each policy area sets forth observations about the plans found in that section. A table following each preface compares the type of plan to its purpose.

The Indices of State Plans section includes three indices. One index lists plans alphabetically by topic. Another index lists the contact persons alphabetically and references the pages on which the plans are described. In all, nearly 100 State personnel have been designated as primary contacts for various State agency plans. The third index, the State Agency index, relates plans to the agencies that produced them.

Policy plans, program plans, study and recommendation plans and combined policy-program plans identified in the State Plans Inventory are prepared at all levels in State government. However, program plans are primarily developed by the division or bureau of a State department while the broader policy plans are prepared at higher levels of State government such as at department or interdepartmental levels.

As a final reminder, it is proposed that the State Plans Inventory be updated biennially. The purpose of this endeavor would be to identify trends in State planning activities and to provide an up-to-date reference in review of State agency federal applications, State plans and direct federal agency activity in Maine. Tables 1 and 2 follow this Introduction identifying State agency plans by policy area and relating them to purpose (Table 1) and to type (Table 2) of plan.

STATE PLANS INVENTORY

This inventory of State Plans has been grouped into eight major areas of policy interest:

- General Government
- Economic Development
- Education and Cultural Services
- Human Services
- Manpower
- Natural Resources
- Public Protection
- Transportation

Each section, covering an area of major policy interest, contains a preface and a table. The preface sets forth general observations about the plans identified in the section while the table indicates the purpose and type of plans found in the section.

A listing of plans identified in the inventory follows the table giving the title, when the plan was issued, its purpose, the type of plan, the person to be contacted for more information and a brief description of the plan. When available, information about the status of implementation of the plan is also given. We will first look at General Government plans.

GENERAL GOVERNMENT

Preface

Plans developed for use by more than one State government agency or for the public at large are included in this section. The State of Maine Budget Document for 1978-79, the Governor's Halfway Point Program Statement (March, 1977), the Commission on Maine's Future Final Report (November, 1977), and the Maine State Policies Plan (1975) are examples of plans and policy documents which cut across general areas of State government to give guidance to a variety of governmental activities. Other, somewhat more specialized plans, include a Comprehensive State Master Plan for Electronic Data Processing (1977), the Maine Capitol Planning Commission Plan for the State Capitol Complex, personnel studies and plans, and State policy affecting the acquisition and disposal of federal surplus property.

Table 3, which follows this preface, relates the type of plan to its purpose. For example, of the four policy plans identified under "type of plan" in the Table, one was drafted to meet federal requirements for funding, two were drafted to satisfy State Legislative requirements; and one was drafted to provide internal departmental policy or program guidance for agency activities. Reading vertically under "Federal Requirement", one policy plan and one program plan are identified as prerequisites for federal funding. A total of eleven plans are identified and described under General Governmental activities.

The Halfway Point covers the Governor's goals and major activities of his administration consisting of a review of the two prior years and the purposes, goals and major actions for the two years ahead. Goals and major actions are proposed and discussed under the general categories of government operations, Economic and Natural Resource Development, Human Resource Development and Conservation of Natural Resources.

Title: Final Report of the Governor's Management Improvement Advisory Committee on Personnel

Issued: December, 1975

Purpose: Internal Policy or program planning purposes

Type of Plan: Study and Recommendation Plan

Description:

Title: Commission on Maine's Future Final Report

Description:

A plan undertaken in response to a State Legislative mandate issued by the 106th Legislature calling for:

1. Proposed growth and development policy for Maine.
2. Reports assembling, analyzing and projecting relevant information regarding the future of the State.
3. An examination of long range plans by State departments and agencies... and an assessment of their possible impact on State growth and development.
4. Reports on the implications of major State decisions.

Though the Report does not meet all legislative mandates, it does present a good case for integrating and interrelating State activities in a more effective manner. In performing this service it discusses the changing population, natural resources, environment, energy, transportation, economic development, education, human needs, housing, health and government. In each of these general categories and sub-categories the Commission sets forth citizen comments, Commission policy recommendations and possible means of implementation.

Description:

The Maine Capitol Planning Commission Report of December, 1976, presents the physical changes that have occurred in the State Capitol Complex since 1969. It proposes changes to the Capitol Complex Master Plan due to changing conditions and changing needs for the provision of State services. This plan has been adopted by the Governor and the State Legislature. It is primarily a site plan for future improvements in the 160-acre complex encompassing State buildings and grounds around the State House in Augusta.

Title: State of Maine Budget Document 1978-1979

Type of Plan: State Budget Plan (Program plan for FY 78-79)

Description:

The State of Maine Budget Document consists of two volumes. Volume One consists of the Governor's budget message, summaries of the State's financial position such as bonded indebtedness, revenues and expenditures, etc., and the Appropriation and Allocation Act which is concerned with the revenues and expenditures of the various State funds the Legislature must act upon. Volume Two, a much thicker document, sets forth departmental and agency actual, estimated and budgeted expenditures for personal services, all other and capital expenses. The departments and agencies are listed under their appropriate general "policy areas", General Government, Economic Development, Education and Culture, Human Services, Manpower, Natural Resources, Public Protection and Transportation. The General fund and other fund levels and personnel and revenue levels are itemized by agency for the past year, the year it is in and for the two years ahead for which resources are budgeted. The State Budget Document, or State Financial Plan, is perhaps the strongest tool the State has for carrying out State policies. The financial plan shows how limited State financial and manpower resources will be allocated.

Title: State of Maine Capital Improvements Program

Issued: Every two years

Purpose: Mandated by State Law

Type of Plan: Program

Description:

By law, the Bureau of Public Improvements is required to submit to the Governor and Legislature a plan for State capital expenditures for the next biennial budgetary period. The plan consists of all State agency requests for capital expenditures. These requests have been screened and prioritized by the Bureau and submitted to the Governor and Legislature with its recommendations and comments.

Title: Federal Expenditures Budget

Issued: Every year (same schedule as for the State Budget)

Purpose: Mandated by State Law

Type of Plan: Program

Description:

The Federal Expenditures Budget is a work plan showing how anticipated federal funds will be spent by identifying and describing specific Federal Programs, State money required for a match, number and type of staff involved and the time period covered. In addition, State agencies indicate which programs they recommend to be discontinued or maintained with State funds if federal funds are withdrawn. Federal funds at the present time constitute approximately one third of Maine's budgetary income.

Title: Comprehensive State Master Plan for Electronic Data Processing

Description:

The Comprehensive State Master Plan for Electronic Data Processing is a plan for consolidating and coordinating the electronic data processing activities of State agencies. It consists of plans for staffing and proposed expenditures of funds to provide better hardware and software services.

Title: State of Maine Draft Plan of Operation: Surplus Property Program

Description:

The plan states the policies and procedures the agency follows in obtaining Federal surplus property, distributing this property and in maintaining its administrative and financial responsibilities. The plan covers all procedures for obtaining and handling federal surplus property, including the type of agencies eligible for receipt of property. The policies and procedures contained in the plan follow the regulations specified by the General Services Administration which administers the Federal Surplus Property Program.

This is a planning study which determines whether or not recruitment and selection activities of the Maine State Department of Personnel have been conceived and developed on a firm foundation of competence, practicality, openness, equality and legality.

ECONOMIC DEVELOPMENT

Preface

Though many State agency plans have an impact on economic development, only plans from the Departments of Agriculture and Marine Resources, the Office of Energy Resources and the State Planning Office are included here as being economic development plans.

Goals for Maine Agriculture sets forth policy, which, if adopted, would strengthen the State's economy through the solution of agricultural issues. The remaining plans identified by the Department of Agriculture are program plans which identify and control the use of pesticides.

Of the four Office of Energy Resources plans, the Maine Comprehensive Energy plan appears to provide an overview of all matters that relate to energy use in the State. Separate emergency contingency and conservation plans have been developed when, perhaps, this material might have been consolidated and interrelated in one plan. Of equal interest is how closely OER's State of Maine Energy Emergency Contingency Plan is related to and coordinated with the Bureau of Emergency Preparedness Natural Disaster Plan.

The Department of Marine Resources Species Management Plans, written from the perspective of increasing and maintaining harvests, contain recommended procedures and policy for administration. Coordination between these species harvest plans and other plans prepared for coastal development will continue and where conflicts arise they undoubtedly will be resolved with the assistance of the Governor's Committee on Coastal Development and Conservation.

The Governor's Task Force report on Economic Development has resulted in proposals for the Maine Development Foundation and the Maine Capitol Corporation being passed by the Legislature. Improved capabilities of the Maine Guarantee Authority, the adoption of a sunset law, and enactment of a State-private tourism promotion and information services bill also resulted from the task force recommendations. Unfortunately, a proposal for a new State planning and budgeting

procedure, which calls for biennial updates of State and regional agency plans and mandated their use in the State budget process, did not pass.

Table 4, which follows this preface, indicates that seventeen plans, the greatest number of plans identified under Economic Development, were developed to provide internal policy or program guidance. Reading horizontally, note that three program plans were drafted to meet federal funding requirements, one to meet State requirements and two for internal program guidance purposes. A total number of twenty-four State agency plans are identified and described in Table 4.

Department of Agriculture

Title: Goals for Maine Agriculture

Description:

This plan is primarily an identification of major issues confronting Maine agriculture, listing those issues expected to continue through the coming decade, and proposing short-run steps for implementation. It seeks to focus the attention of both public and private institutions on these issues in order to set priorities for the allocation of resources needed to develop solutions. The Plan names eight goals which, if reached by the Maine agricultural community, would strengthen the farm economy and preserve valuable natural resources.

Status of Implementation:

The Department currently is developing more specific strategies in response to the Governor's request.

Title: State Plan for Certification of Pesticide Applicators

Issued: January, 1976

Purpose: To meet a Federal requirement

Type of Plan: Program

Contact: Donald Mairs, 289-2215 (Pesticides Control Board)

Description:

This Plan lays out how the State of Maine proposes to certify those citizens who wish to purchase and use restricted insecticides. It covers agency responsibility, legal authorities, conformance to standards of competency, categories of private and commercial applicators, licensing of pesticide dealers, reciprocity with other states, and maintenance of the plan.

Status of Implementation:

This Plan was implemented May 1, 1977.

Title: Interim Certification to Register Pesticides to Meet Special Local Needs

Issued: Certified by EPA on November 20, 1975; amended in August, 1976

Purpose: To meet a Federal requirement, under Section 24(c) of the Federal Insecticides, Fungicide and Rodenticide Act (FIFRA) as amended

Type of Plan: Program

Description:

Federal law currently requires all pesticide products to be registered and to be used in a manner consistent with registered labels, whether these products are distributed inter- or intra-state. However, occasionally there is a need for pesticide use, or method of application, or change in site, etc., within an individual state which would not be consistent with the federally registered label. This program plan, once certified by the Administrator of the Environmental Protection Agency, authorizes the State of Maine to issue pesticide registrations for changes in product/uses/sites, etc. (within the confines of Section 24(c) of the FIFRA) when there is determined to be a need for making available a use or product for the control of certain pests.

Status of Implementation:

This is an interim plan, currently used, yet subject to changes, if any, as may be dictated by finalization of program regulations for Section 24(c) of FIFRA.

Office of Energy Resources

Title: State Agency Energy Conservation Plan

Issued: January, 1976

Purpose: Prepared for internal planning purposes

Description:

This Action Plan was developed and implemented to reduce energy consumption by State agencies and in State facilities. A side benefit will be a reduction of expenditures for energy, thereby achieving budget savings. The Plan discusses and evaluates methods and procedures by which State agencies can reduce their energy consumption.

Title: Maine Comprehensive Energy Plan - 1978 Revised Draft

Coordination with various other involved bodies and institutions (e.g., NEPOOL) is stressed.

EDUCATION AND CULTURAL SERVICES

Preface

An Administrative Council, consisting of the bureau heads of the Department of Education and Cultural Services has been established to assist the Commissioner in administering his department. This Council, with support from the State Board of Education and other Departmental Commissions, has drafted a mission and goals statement. Eight general goals have been adopted, together with subgoals identifying general objectives for the Department.

Within the Department the following commissions and boards have been created to develop and implement plans:

State Board of Education -- serves as a citizen's advisory board as well as providing a limited policy making role in school accreditation, establishing or dissolving school administrative districts, and in matters related to vocational technical institutes.

State Museum Commission -- appointed by the Governor to set policy for the Bureau of Museum.

State Historic Preservation Commission -- consists of State agency representatives and gubernatorial appointees who review and approve proposed programs.

State Arts and Humanities Commission -- also consists of gubernatorial appointees who review and approve proposed bureau plans and programs.

State Library Commission -- consists of gubernatorial appointees, but is purely advisory in function.

Table 5 that follows this preface relates the purpose of those plans identified under Education and Culture to the type of plan created. Note that over half of the plans created have been drafted to meet federal funding requirements which has prompted planners in the Department to express the wish that annual program cycles be extended to cover a 3-5 year cycle. This would eliminate an essentially repetitive task and place emphasis on long range planning to meet needs. Eight plans have also been drafted to provide program guidance to departmental and agency activities. A total number of twenty-four plans have been identified under Education and Culture.

HUMAN SERVICES

Preface

The State Department of Human Services administers most of the State programs that pertain to medical and general health services. The State Housing Plan, that relates to people and their housing needs, is also placed in this functional category of State planning activities even though the State Planning Office drafted the plan. Similarly, the plan for Weatherization Assistance for Low Income People prepared by the Division of Community Services in the Executive Department is also found in this category.

Further complicating the neat arrangement of locating all plans related to human services in the human service category is the close interrelationship of the special supplemental food program administered by the Department of Human Services with the school lunch and breakfast programs administered by the Department of Educational and Cultural Services. Vocational Rehabilitation programs also cross the departmental boundaries of Educational and Cultural Services and Manpower Affairs. The Drug Abuse Prevention Plan of the Department of Human Services is a plan that crosses functional and departmental boundaries which is of concern to and a part of the Comprehensive Criminal Justice Plan produced by the Maine Criminal Justice Planning and Assistance Agency. Examples of planning activities that cross functional planning as well as departmental boundaries are numerous, thus requiring a continuing surveillance of State planning activity with the necessary follow-up to either consolidate, coordinate or abolish duplicative planning activities.

In Human Services planning, most plans have been developed to meet Federal requirements. Most of the plans drafted have been program or policy-program type plans. As in the other general functional planning activity areas, much still remains to be done to develop a comprehensive planning capability for the human services activity area.

MANPOWER

They are produced essentially in response to federal program requirements and guidelines and are done for the over-riding purpose of qualifying the State to receive federal money for a variety of manpower training and subsidy programs geared to specific target populations. Overall, integrated and coordinated manpower planning rests, to some extent, with the State Manpower Services Council, located within the Executive Department, but no comprehensive State manpower plan, as such, has yet been developed.

Other manpower related plans are also prepared in the Department of Education and Cultural Services, especially vocational education and training program plans.

Table 7 follow this preface. A total of eight plans have been identified under Manpower -- all of which have been prepared to meet federal funding requirements. Four of these plans are program plans and four constitute combined policy-program plans.

NATURAL RESOURCES

Preface

The State Departments of Conservation, Environmental Protection, and Inland Fisheries and Wildlife, as well as the State Planning Office and the Baxter State Park Authority, develop plans related to the use of the State's natural resources. Half of these plans are prepared by the various bureaus of the Department of Conservation.

The important forest resource of the State is covered by the Maine Forest Service Policy Plan which provides general direction for the Bureau of Forestry's programs. In addition, separate plans deal with forest fire prevention, pre-suppression, suppression and control and with spruce budworm damage control.

The Maine Geological Survey plan deals with hydrological, marine and physical geology programs. It provides resource data collection on a fixed schedule in accordance with the Five Year Program Plans For Physical Resources Inventory, 1977-1982.

The Land Use Regulation Commission has adopted a Comprehensive Land Use Plan (September, 1976), which sets forth guidelines for permanent zoning of the State's unorganized townships which is now being implemented. This plan and the State land use element being prepared by the State Planning Office should be continually reviewed to insure that conflicting objectives do not occur.

Park system plans are in preparation and a program plan has been developed by the Baxter State Park Authority. These plans are coordinated within the Statewide Comprehensive Outdoor Recreation Plan (SCORP), which is updated every five years.

The management plan for public lands held by the Bureau of Public Lands is being used in developing site specific plans for State owned lands. In addition, a Coastal Island Management Plan is in preparation that will contain policy for administration of islands under jurisdiction of the Bureau.

Plans prepared by the Department of Environmental Protection deal with air quality control, solid waste management, basin water quality management, and areawide waste water treatment. These are in varying stages of development and are used to carry out land, water and air pollution abatement programs as required under State and federal legislation.

The Department of Inland Fisheries and Wildlife has prepared management plans for all inland fish and wildlife species.

The study and recommendation plan, Management of Water and Related Land Resources in the State of Maine, prepared by the State Planning Office in 1975, has resulted in the establishment of a Land and Water Resources Council. This Council, consisting of Commissioners and directors of State agencies concerned with natural resources planning and management, is responsible for developing a comprehensive, integrated land and water resources planning and management program for Maine. The State Planning Office has also completed a State land use element which identifies and analyses the present State resource planning and management system and will eventually lead to a State growth plan.

Table 8 on the next page indicates that the largest number of plans identified in the functional area of natural resource planning were prepared for internal policy or program development. Six plans, including policy, program and study and recommendation plans, were prepared to meet federal funding requirements. In all, twenty-seven plans are identified under natural resources planning activities.

Description:

The capability to deal with the cumulative impact of growth on the coast was addressed by Land Use Consultants, Inc., of Portland for the Department of Environmental Protection. The cumulative impacts considered by the study include the total effects of commercial and residential development on open space, socio-economic conditions, the availability of public facilities, the natural environment and aesthetics.

The findings and recommendations of the report focus on the need for the state to develop adequate data and analytical techniques to identify potential cumulative impact problems before they become uncorrectable without major difficulty, and on changes in both state and local laws to specifically address the problem of cumulative impacts. The report also finds that regional planning commissions, as presently structured, are not likely to be able to deal effectively with cumulative impacts and recommends changes in the funding of RPC's and the relationship between the state, county, RPC's and towns.

The Governors' Committee on Coastal Development and Conservation is using the report to prepare policy recommendations to be submitted to the Governor by October 31, 1978.

Preface

The Comprehensive Criminal Justice Plan and its State correctional component are the principal plans identified in the category of public protection. These plans concern police, courts, corrections, juvenile justice and public information and education activities which relate to the criminal justice system. The Maine Criminal Justice Planning and Assistance Agency, a branch of the Executive Department, is responsible for development of these plans.

The Department of Defense and Veterans Services has developed several plans, predominantly dealing with protection of the public from natural or man-made disasters. Under preparation is a State of Maine Nuclear Crisis Relocation Plan which hopefully will utilize information obtained from the prepared State of Maine Natural Disaster Plan and attempt to coordinate these program plans.

Most of the plans prepared by State agencies concerned with Public Protection have been done to meet federal funding requirements. Nearly all of these plans are characterized as being policy-program plans as seen on Table 9 that follows this preface. It will also be noted that a total of seventeen plans have been identified under public protection planning activities.

TRANSPORTATION

Preface

The Department of Transportation is a strong department controlled by the Commissioner of Transportation, a gubernatorial appointee. Three advisory committees, the Maine Highway Safety Committee, the Ferry Service Committee, and a newly authorized and appointed Advisory Committee on Aeronautics, assist the Commissioner in administering his programs.

The types of plans produced by the Department of Transportation are program, combined policy-program and study and recommendation plans. Half of the plans produced by the Department fulfill federal requirements. Most of the plans are based on considerable mapping and data analysis that provide guidance and support for State and federal expenditures of funds to maintain and improve the State's transportation system.

However, not all of the reports listed in this section are considered plans. For example, the Highway Planning and Research Program and the Highway and Bridge Improvement Program documents are not considered by DOT staff as plans. Instead, they are viewed, as the "tools" for carrying out Departmental policies. The Departmental policies for identification and prioritization of projects for highway and bridge maintenance and improvement funding are achieved through Departmental deliberations based on highway and bridge improvement programs and highway sufficiency reports, a highway accident analysis, maintenance engineers reports, valid project requests, special studies and public hearing results.

This study has sought to determine the potential for new or expanded cargo-handling port facilities in the State. Particular emphasis was placed on a facility with the capability of handling the wide range of forest products produced in Maine. Major impetus for this study was the State's desire to have more of its exports and imports move through Maine's ports, if such movement could be found to be practical and economical. An examination of existing ports presently handling general cargo revealed that the Portland and Searsport areas are the most suitable as a site for a cargo port development project. Five alternative courses of action were evaluated based on the results of engineering and marketing analyses. The study concludes that a new cargo facility be constructed at Searsport at a cost of approximately \$41 million.
